MINUTES

The Prairie Heights Community Schools Board of Education met in regular session on Tuesday, September 15, 2009. The meeting was held in the Administration Office. The meeting was called to order by President Mike Howe at 7:00 p.m. with the Pledge of Allegiance and a reading of the Mission Statement.

Mr. Noll reported on FFA members that participated in the FFA State Convention and awards that were given. He also announced that Laney Kratz will be running for a National Office in October at the National Convention. Mr. Leu announced that Kyle Stockwell is a National Finalist in his SAE. The Heritage Festival will be October 11 from 11:00 am to 5:00 pm.
