The Prairie Heights Community Schools Board of Education met in regular session on Tuesday, July 21, 2009. The meeting was held in the Administration Office. The meeting was called to order by President Mike Howe at 7:00 p.m. with the Pledge of Allegiance and a reading of the Mission Statement.

A motion was made by Todd Perkins to approve the following Consent Items:
