## **MINUTES**

The Prairie Heights Community Schools Board of Education met in regular session on Monday, November 13, 2023 at 6:00 pm. The meeting was held in the administration office. A motion was made by Heather Culler to approve the following consent items:

The motion was seconded by Jesslyn Senecal and approval was 5-0.

Time was allotted for public input on the proposed contract between the Prairie Heights Community School Corporation and the Prairie Heights Education Association.

Deb Snyder read a statement regarding the bargaining process from the PHEA.

A motion was made on the following Action Items:

- Aaron Pfafman moved to ratify the tentative agreement reached with the Prairie Heights Education Association effective July 1, 2023 – June 30, 2025. Heather Culler seconded the motion and approval was 5-0
- Mike Howe moved to approve the Compensation Amendment 23-Admin. Jesslyn Senecal seconded the motion and approval was 5-0.
- Jesslyn Senecal moved to approve a Supplemental Payment to Certified Staff. Aaron
  Pfafman seconded the motion and approval was 5-0. (Full time employees will receive
  \$5000.00 and part time employees will receive \$2500.00. If the employee was hired
  during the 2023-2024 school year, they will receive 80% of the stipend split into two
  different installments. The first installment will be in December 2023 and the second
  will be after count day in the fall of 2024, if they remain employed with the corporation.)
- Mike Howe moved to approve the proposed pay increases for Classified Staff and Bus Drivers. Heather Culler seconded the motion and approval was 5-0. (\$1500.00 260 day employees, \$1000.00 full time employees, \$0.50 per hour for part time employees, \$5.50 increase per day for bus drivers)
- Aaron Pfafman moved to approve a one-time stipend payment for Classified Staff and Bus Drivers. Heather Culler seconded the motion and approval was 5-0. (\$5000.00 for full time employees, \$2500.00 for part time employees, and \$3000.00 for bus drivers. If the employee was hired during the 2023-2024 school year, they will receive 80% of the stipend split into two different installments. The first installment will be in December 2023 and the second will be after count day in the fall of 2024, if they remain employed with the corporation.)

Mr. Reed thanked the bargaining team for working well together.
