## **MINUTES**

The Prairie Heights Community Schools Board of Education met in regular session on Monday, August 15, 2011. The meeting was held in the Administration Office. The meeting was called to order by President Mike Howe at 7:00 p.m. with the Pledge of Allegiance and a moment of Silence.

A motion was made by Mark Thrasher to approve the following Consent Items:

- Resignations accepted by Mr. Middleton from Jennifer Wells (PHHS Special Education Teacher), Sean Maxwell (PHMS Teacher), Tyler Terry (Freshman boys basketball coach) and Dakota Smith (JV boys basketball coach).

The motion was seconded by Janet Grabill and approval was 5-0.

Motions were then made on the following Action Items:

- Bob Ledgerwood made a motion to approve the Compensation Guide Amendment for 2011-2012.
   Mark Thrasher seconded the motion the motion passed 5-0.
- Mark Thrasher made a motion to approve the advertisement of the 2012 budget. There will be a public hearing on September 6<sup>th</sup> regarding the budget. Todd Perkins seconded the motion and the motion passed 5-0.
- □ Janet Grabill made a motion to approve the building financial reports. Bob Ledgerwood seconded the motion and the motion passed 5-0.
- □ Todd Perkins made a motion to include the 2 mobile classrooms at Milford Elementary in the auction this fall. Janet Grabill seconded the motion and the motion passed 5-0.
- □ Todd Perkins made a motion to loan the building trades tools to the Four County Area Vocational program for 5 years. After 5 years if the program is still in session the tools will be donated, if the program is not in session the tools will come back to Prairie Heights. Janet Grabill seconded the motion and the motion passed 3-2.

Mark Thrasher made a motion to approve the pilot student day changes for 2011-2012. The student day will begin at 8:30 am in all buildings. Prairie Heights Elementary will dismiss at 3:37, Prairie Heights Middle School will dismiss at 3:38 and Prairie Heights High School will dismiss at 3:43. Todd Perkins seconded the motion and the motion passed 5-0.

Mr. Middleton reported the 2011-2012 school year will have 24 pays.
